Approval of February 13, 2018, meeting minutes

Mr. Steinfeld offered an edit that corrected the spelling of his second name (from "Ingles" to "Inglis").

Motion: Dr. Mock motioned to approve the minutes as amended. Mr. Boulger seconded the motion. Motion passed.

Discussion of operational definitions-continued

Ms. Rubin presented an operational definitions flowchart representing the most likely outcomes for ARI participants. Ms. Rubin asked committee members for suggestions and feedback. The following suggestions were made:

• Revise the definition of revocation: "The number of participants in an ARI-funded program whose probation was terminated and who were sentenced to an alternative sanction, such as another type of probation, or jail or IDOC."

- Draft a definition for "subsequent admission to IDOC" to capture everyone who ends up in IDOC after participating in ARI programming, regardless of whether they dropped out, recidivated, or were revoked.
- Draft a definition of "transfer" and make a distinction between "jurisdictional transfer" and "administrative transfer."
- The committee reaffirmed its definition of recidivism: "enrolled persons who receive a new conviction of a Class B misdemeanor, Class A misdemeanor, or felony offense within one year of ARI-funded program discharge, regardless of discharge type.
- Draft two definitions of "diversion" one for research purposes and one for funding purposes. One definition should be "enrolled diverted," referring to the total number of new participants enrolled in an ARI-funded program within one year. The other definition should be "active diverted," referring to new enrollments as well as active (compliant) participants in an ARIfunded program who have not been sent to IDOC in that year.

Action Item: ARI staff will consider the suggestions made by committee members and revise the operational definitions discussed accordingly.

Old business/new business

Ms. Pérez asked committee members for their availability to schedule future meeting dates.

Action Item: Committee members will review proposed dates for future meetings.

Mr. Boulger suggested the Outreach, Technical Assistance & Communication Committee revisit the Crime Reduction Act and the definitions within the statute and update them to reflect current Illinois probation operations.

Ms. Dyar said an effort was under way to change the Crime Reduction Act to eliminate the restriction preventing the use of ARI funds to serve individuals convicted of violent offenses. This would allow local jurisdictions to serve individuals based on probation eligibility and not the nature of the offense with which they were charged.
