## Victimologist - Research and Analysis Unit

The Illinois Criminal Justice Information Authority ("the Authority"), based in downtown Chicago, is seeking qualified candidates for the position of Victimologist in the agency's Research and Analysis Unit, which operates as the State's Statistical Analysis Center (SAC). Under the direct supervision of the Associate Director of Research, the Victimologist performs a variety of activities related to the design, execution, and management of victim-centered research projects for the purpose of guiding and informing the state's criminal justice practice, policy and funding decisions.

The Victimologist interprets and explains victim program design, goals, objectives, and outcomes to legislator's community service programs, local law enforcement agencies and various committees; answers questions and distributes information about victim programs and develops briefings for the Associate Director and Executive Director. The Victimologist conducts in-depth research; defines the requirements of crime reporting programs; accesses and manipulates multiple, large data sources and synthesizes related information to structure an argument in support of Authority decisions concerning practices, policies and funding; determines and designs research methods; writes and executes questionnaires; analyzes results and writes final reports; develops program goals and objectives; directs and evaluates program activities to ensure program policies and procedures are implemented by community services agencies and local police authorities; and examines whether the implemented programs result in expected outcomes.

An ideal candidate would possess several of the following attributes:

- Master's Degree in criminology, criminal justice, political science, psychology, sociology or other relevant discipline; Ph.d. preferred
- Three years of experience conducting criminal justice research, particularly that involving victims and victimization
- Experience synthesizing large bodies of criminal justice and victim-related research in user-friendly formats
- Experience designing, executing and managing large research projects, including project budgeting
- Experience guiding and directing junior research staff
- Demonstrated working experience with statistical methods and models
