Integration survey conducted to drive strategic planning

CJIA researchers are analyzing responses of more than 500 criminal justice practitioners who were surveyed in spring 2009 to obtain a better understanding of the information sharing needs and practices of criminal justice agencies across the state.

Surveys were sent to county sheriffs, state's attorneys, circuit court clerks, public defenders and probation departments in each Illinois county, as well as a random sampling of local police departments. Survey results will assist the IIJIS Implementation Board and its committees in strategic planning of policies, technologies, and funding resources that meet operational needs of participating justice agencies and address the increasing information demands of society.

About IIJIS

C reated in 2003, the IIJIS Implementation Board is an intergovernmental entity dedicated to facilitating the electronic sharing of justice information throughout Illinois.

IIJIS is a collaborative effort to enhance public safety by making complete, accurate, and timely information available to all justice decision-makers. Day-to-day work of IIJIS is carried out by ICJIA staff.

The IIJIS Implementation Board promotes electronic justice information sharing by coordinating the development, adoption, and implementation of plans for systems designed to help positively identify individuals, provide offender status and history information, electronically exchange case information as it flows through the justice system, and share police incident report data.

The responsibilities of the Implementation Board also include establishing standards to facilitate the electronic sharing of justice information, protecting individual privacy rights related to the sharing of justice information, and coordinating the funding of integration efforts.

Integration leaders convene at 2009 IIJIS Summit

ore than 160 integrated justice stakeholders attended the September 2009 Illinois Integrated Justice Information System Summit in Rosemont.

Hosted by the IIJIS Implementation Board, the event highlighted successful local and county criminal justice integration efforts, shared grant strategies, and provided the latest information on the Illinois integrated justice system initiative.

The event featured local and nationally recognized experts who shared information on integration best practices, national trends on integrated justice information sharing, and obtaining grant funding. The summit put a spotlight on integration success stories in Illinois, and best practices currently being utilized in information sharing.

Topics included integration grant trends and research, integration projects for mental health, justice stakeholder partnerships for electronic ticketing, approaches to building an electronic court and lessons learned.

The event was open to a variety of criminal justice professionals, including law enforcement officials, state, county, and local government leaders, court and probation personnel, state's attorneys, and public defenders.
