Because a large focus of our strategic direction is currently the work at the local level of the county coordinating Councils and Redeploy boards, we are combining our Strategic Opportunities (SOC) and Coordinating Council Advisory Committee (CCAC) meetings this quarter. The meeting will be held on Thursday, April 19, from 2:00-3:00 p.m. at ICJIA's office at 300 West Adams, Chicago, Suite 200.

First, we want to give an overview of the upcoming joint conference of Adult Redeploy and Criminal Justice Coordinating Councils entitled "Data, Planning, and Impact: A Joint Adult Redeploy Illinois and Criminal Justice Coordinating Councils Summit." Hosted by ICJIA, Adult Redeploy Illinois, and Loyola University's Center for Criminal Justice Research, Policy, and Practice, the Summit will bring together a broad range of stakeholders from counties and judicial circuits either operating or interested in developing CJCCs and ARI-funded local prison diversion programs. By combining CJCC and ARI programing in a single summit, we hope to provide rich opportunities for mutual learning and foster discussions about coordinated decision-making. We ask for your input on strategies to make the most of this convening. An agenda for the summit is attached.

Next, we want to discuss what steps ICJIA should take to follow up on the summit. One challenge is to sustainably expand our outreach to new counties to provide technical assistance to criminal justice coordinating councils and other collaborative groups. While we have committed to providing technical assistance to our five county partners through the end of 2018, we would like to find ways to continue to support collaborative criminal justice planning efforts in these counties and in other interested jurisdictions, and identify ways that other collaborative groups (Family Violence Coordinating Councils, Adult Redeploy, etc.) could benefit from these efforts as well.

We look forward to your participation and guidance.
