# (20 ILCS 4005/) Illinois Motor Vehicle Theft Prevention Act.

The purpose of this Act is to prevent, combat reduce motor vehicle theft in Illinois; to improve and sup motor vehicle theft law enforcement, prosecution and administration of motor vehicle theft laws by establishing statewide planning capabilities for and coordination of financial resources.

The Governor from time to time shall designate the Chairman of the Council from the membership. All members of the Council appointed by the Governor shall serve at the discretion of the Governor for a term not to exceed 4 yea: The initial appointed members of the Council shall serve: January 1, 1991 until the third Monday in January, 1995 of until their successors are appointed. The Council shall meat least quarterly.

   Sec. 7. The Council shall have the following powers,
  duties and responsibilities:
  - (a) To apply for, solicit, receive, establish priorities for, allocate, disburse, contract for, and spend funds that are made available to the Council frany source to effectuate the purposes of this Act.
  - (b) To make grants and to provide financial supportion for federal and State agencies, units of local governor corporations, and neighborhood, community and business organizations to effectuate the purposes of this Act.
  - (c) To assess the scope of the problem of motor vehicle theft, including particular areas of the State where the problem is greatest and to conduct impact analyses of State and local criminal justice policies programs, plans and methods for combating the problem
  - (d) To develop and sponsor the implementation of statewide plans and strategies to combat motor vehicle theft and to improve the administration of the motor vehicle theft laws and provide an effective forum for identification of critical problems associated with movehicle theft.
  - (e) To coordinate the development, adoption and implementation of plans and strategies relating to interagency or intergovernmental cooperation with resp to motor vehicle theft law enforcement.
  - (f) To promulgate rules or regulations necessary ensure that appropriate agencies, units of government private organizations and combinations thereof are included in the development and implementation of strategies or plans adopted pursuant to this Act and promulgate rules or regulations as may otherwise be necessary to effectuate the purposes of this Act.
  - (g) To report annually, on or before April 1, 1992 the Governor, General Assembly, and, upon request, to members of the general public on the Council's activing the preceding year.
- (h) To exercise any other powers that are reasonal necessary or convenient to fulfill its responsibilition to carry out and to effectuate the objectives and purp of the Council and the provisions of this Act, and to comply with the requirements of applicable federal or State laws or regulations; provided, however, that suppowers shall not include the power to subpoena or arrows.

  Sec. 8. (a) A special fund is created in the State
  Treasury known as the Motor Vehicle Theft Prevention Trust
  Fund, which shall be administered by the Executive Direct
  the Authority at the direction of the Council. All interes
  earned from the investment or deposit of monies accumulate
  the Trust Fund shall, pursuant to Section 4.1 of the State
  Finance Act, be deposited in the Trust Fund.
- (b) Money deposited in this Trust Fund shall not be considered general revenue of the State of Illinois.
- (c) Money deposited in the Trust Fund shall be used on to enhance efforts to effectuate the purposes of this Act determined by the Council and shall not be appropriated, loaned or in any manner transferred to the General Revenue Fund of the State of Illinois.
- (d) Prior to April 1, 1991, and prior to April 1 of ear year thereafter, each insurer engaged in writing private passenger motor vehicle insurance coverages which are inclin Class 2 and Class 3 of Section 4 of the Illinois Insura Code, as a condition of its authority to transact business this State, may collect and shall pay into the Trust Fund amount equal to \$1.00, or a lesser amount determined by tl Council, multiplied by the insurer's total earned car year private passenger motor vehicle insurance policies provide physical damage insurance coverage written in this State during the preceding calendar year.
  - (e) Money in the Trust Fund shall be expended as follow (1) To pay the Authority's costs to administer the Council and the Trust Fund, but for this purpose in all amount not to exceed ten percent in any one fiscal year the amount collected pursuant to paragraph (d) of this Section in that same fiscal year.
  - (2) To achieve the purposes and objectives of this Act, which may include, but not be limited to, the following:
    - (A) To provide financial support to law enforcement and correctional agencies, prosecutor, and the judiciary for programs designed to reduce motor vehicle theft and to improve the administration of motor vehicle theft laws.
    - (B) To provide financial support for federal a State agencies, units of local government, corporations and neighborhood, community or busing organizations for programs designed to reduce mote vehicle theft and to improve the administration of motor vehicle theft laws.
    - (C) To provide financial support to conduct programs designed to inform owners of motor vehiclabout the financial and social costs of motor vehicle theft and to suggest to those owners methods for preventing motor vehicle theft.
    - (D) To provide financial support for plans, programs and projects designed to achieve the purpof this Act.
- (f) Insurers contributing to the Trust Fund shall have property interest in the unexpended money in the Trust Fundamental Fund

which property interest shall not be retroactively changed extinguished by the General Assembly.

(g) In the event the Trust Fund were to be discontinuathe Council were to be dissolved by act of the General Assembly or by operation of law, then, notwithstanding the provisions of Section 5 of the State Finance Act, any balaremaining therein shall be returned to the insurers writing private passenger motor vehicle insurance in proportion to their financial contributions to the Trust Fund and any as of the Council shall be liquidated and returned in the sammaner after deduction of administrative costs.
