RE: Restore, Reinvest, and Renew (R3) Emergency Summer Violence Response Pilot

NOTICE OF FUNDING OPPORTUNITY

Staff recommends setting aside \$3,000,000 in Restore, Reinvest, and Renew (R3) funding for an Emergency Summer Violence Response Pilot Program Notice of Funding Opportunity (NOFO). In the City of Chicago, monthly crime trends indicate that violent crime totals are highest during summer months. We looked at violent crime data gathered by the Chicago Police Department. The data from 2010-2020 show that violent crime totals are routinely the highest from June to August.¹ Given the consistency of this pattern, we expect the trend to continue in 2021.

The data also shows a disturbing trend for key violence indicators, such as murder and aggravated battery w/firearm (non-fatal shooting incidents). So far in 2021, the totals for murder and aggravated battery w/ firearm (non-fatal shooting incidents) are higher than they were this time last year in 2020.² If this pattern continues, then summer murder and aggravated battery with firearm totals will also be higher in 2021.

Chicago is not the only Illinois city in need of violence prevention resources. Other large urban areas in Illinois also experience high violent crime and may experience an increase in violent crime this summer.

Therefore, this NOFO will be focused on the following cities and regions:

Applicants must be currently operating a youth development, youth employment or street intervention program that can be increased quickly over the summer months. Applicants must have at least two years of experience to apply and have the capacity and ability to operate the program independently (i.e., no collaboratives, sub-grantees, or fiscal agents will be accepted). ICJIA grantees with R3 and/or violence prevention funding that covers this period of performance are not eligible to apply.

The award range is a minimum of \$50,000 to a maximum of \$300,000. The expected period of performance will be July 1-September 30,2021. Selected applicants to be presented to the R3 Board and the ICJIA Budget Committee in late June. Staff will be available at the Budget Committee meeting to answer any questions.
