5-A. Violence Prevention and Reduction

New Designation

The Budget Committee designated \$709,650 in SFY22 Violence Prevention and Reduction (VPR) funds the Austin Peoples Action Center to provide community focused events, local public service announcements, and community discussions around using social media as a tool that can be used to improve community and personal relationships.

5-B. American Rescue Plan Act

New Notices of Funding Opportunity

The Budget Committee approved two Notices of Funding Opportunities (NOFOs) using American Rescue Plan Act (APRA) funds:

- 1. A NOFO for street intervention programs for \$1,000,000 over two years.
- 2. A NOFO for violence prevention and will be for \$12,566,456 over two years

The goal of both NOFOs will be to fund programs located in geographic gap areas that do not currently receive funding by Reimagine Public Safety Illinois, City of Chicago, or funding by Restore, Reinvest, and Renew (R3). The award range is a minimum of \$50,000 to a maximum of \$200,000. The expected period of performance will be September 1, 2022 - October 31, 2023. Selected applicants in good standing would be eligible for up to one additional year of renewed funding, contingent on state appropriation.

The Budget Committee tabled a recommendation to designate \$500,000 to Ex Cons for Community and Social Change to provide mentorship support, Social and Emotional Learning service provision, art therapy, street safety program, violence prevention programs, renovate classrooms. 5-C. Bullying Prevention

New Notice of Funding Opportunity

The Budget Committee approved the use of \$400,000 in Bullying Prevention (BP) funds to support a NOFO to be issued in Spring 2022 in anticipation of a SFY23 BP appropriation. The intent is to fund approximately five to six grants across Illinois with awards ranging between \$65,000 and \$75,000. The NOFO will be directed toward schools and community-based agencies. The NOFO will ask applicants to address bullying prevention through positive school climate activities, supportive services for those experiencing bullying, and/or education and awareness to address those who have used bullying behaviors.

5-D. Statewide Deferred Prosecution

New Designation

The Budget Committee approved a designation of \$1,500,000 in direct line-item appropriated Statewide Deferred Prosecution funds to Winnebago County to support the DIVERT program. The DIVERT program will implement both diversion and deferred prosecution programs and will occur at the pre-trial or prosecution phase.

5-E. Restore, Reinvest, and Renew

New Notice of Funding Opportunity

Staff described upcoming actions related to the selection and designation of SFY23 Restore, Reinvest, and Renew (R3) grants. Staff shared information intended to prepare members of the Budget Committee for the May 16, 2022 special Budget Committee meeting to make those designations. This item was presented for informational purposes only; no action was necessary, and none was taken.

Under the Authority's rules, members shall be notified of all motions passed by a particular committee within 5 business days of any committee meeting, or prior to the next meeting of that committee, or before the next meeting of the Authority, whichever is sooner. Within 10 business days of this notice, a special meeting may be convened upon the request of 5 Authority members to discuss any action taken by a committee and to supersede the action. 2 IL Adm. Code 1750.340(i).
