# FREQUENTLY ASKED QUESTIONS Coronavirus Emergency Supplemental Funding Program

## I was notified that my jurisdiction is eligible for a Coronavirus Emergency Supplemental Funding Program grant. Where can I get more information?

The Coronavirus Emergency Supplemental Funding (CESF) Program will provide funding to assist eligible states, local units of government, and tribes in preventing, preparing for, and responding to the coronavirus. CESF funds must be utilized to prevent, prepare for, and respond to the coronavirus. Allowable projects and purchases include, but are not limited to, overtime, equipment (including law enforcement and medical personal protective equipment), hiring, supplies (such as gloves, masks, sanitizer), training, travel expenses (particularly related to the distribution of resources to the most impacted areas), and addressing the medical needs of inmates in state, local, and tribal prisons, jails, and detention centers

No. Your jurisdiction must apply <u>independently and directly</u> to the US. Bureau of Justice Assistance to receive this funding.
