A. Program Description

Adult Redeploy Illinois (ARI) is a state initiative to reduce the number of non-violent offenders entering prison. ARI provides financial incentives to counties or judicial circuits to increase community-based supervision and services that are proven to reduce recidivism as safe alternatives to incarceration. In exchange for funds, ARI sites agree to reduce by 25 percent the number of people they send to the Illinois Department of Corrections (IDOC) from targeted populations. The reduction in incarceration saves the state money and a portion of the savings are used to sustain ARI and the local programs it supports. ARI has grown from five county sites in 2011 to 19 sites in 38 counties in State Fiscal Year 2017 (SFY17). ARI planning grants and subsequent local planning activities are a key component of the steady growth of ARI.

Planning Grants

Adult Redeploy Illinois planning grants are available contingent on funding. Counties can apply for planning grants to convene stakeholders, analyze data, and conduct other activities to determine how best to implement a local ARI program to divert non-violent offenders from prison into community-based supervision and services. By the end of the planning grant period, funded jurisdictions must complete and submit a local ARI implementation plan using the standard plan template (available at http://www.icjia.state.il.us/redeploy/standard-plan.cfm). Note that funded jurisdictions are under no obligation to implement the plan. Planning grant periods are generally three to six months. Grant activities and expenses may include, but are not limited to:

- Employing an outside facilitator or strategic planning consultant.
- Conducting an outside or in-house data analysis.
- Providing stakeholder training.
- Conducting site visits to observe successful diversion programs.
- Community resource mapping.

Authorizing Statutes

Adult Redeploy Illinois was created through the Illinois Crime Reduction Act [730 ILCS 190/20(d).] which outlines the program and creates a governing Oversight Board. The Crime Reduction Act provides financial incentives to local jurisdictions for programs that allow diversion of non-violent offenders from state prisons by providing community-based services and supervision through the ARI program. Pursuant to the Crime Reduction Act, the General Assembly has obligated funds for the ARI program to provide financial incentives to local jurisdictions through the Authority on behalf of the Adult Redeploy Illinois Oversight Board. Planning grant funds will be made available pursuant to the Authority's rules entitled "Operating Procedures for the Administration of Non-Federal Funds" (20 Illinois Administrative Code 1560 et seq.) and pursuant to the ARI Oversight Board designating the Implementing Agency to receive funds for the purpose of activities that plan for the implementing of an ARI program.

Goals, objectives and performance measures

Goal: Develop a strategy (local plan) to increase local capacity to provide supervision and services to a target population of non-violent offenders who would otherwise be incarcerated. The plan is to be submitted to the Adult Redeploy Illinois Oversight Board no later than May 12, 2017.

B. Funding Information

ARI planning grant funds became available through Public Act 099-0524. A maximum of \$100,000 will be made available through this planning grant opportunity. A county or a group of counties may request up to \$30,000. In past years, counties and groups of counties have been awarded planning grants ranging from \$3,500 to \$30,000. Funding is available for the period of November 14, 2016, through May 12, 2017. See section D (funding restrictions) for information on allowable and unallowable costs.

Agreements that result from this funding opportunity are contingent upon and subject to the availability of funds. The Authority, at its sole option, may terminate or suspend this agreement, in whole or in part, without penalty or further payment being required, if (1) the Illinois General Assembly fails to make an appropriation sufficient to pay such obligation, or if funds needed are insufficient for any reason (30 ILCS 500/20-60); (2) the Governor decreases the Authority's funding by reserving some or all of the Authority appropriation(s) pursuant to power delegated to the Governor by the Illinois General Assembly; or (3) the Authority determines, in its sole discretion or as directed by the Office of the Governor, that a reduction is necessary or advisable based upon actual or projected budgetary considerations. The Implementing Agency will be notified in writing of the failure of appropriation or of a reduction or decrease.

C. Eligibility

Any Illinois county or a group of counties may apply for an ARI planning grant. Under the Illinois Crime Reduction Act [730 ILCS 190/20(d).], only counties or groups of counties can access ARI funding. Additionally, in order to be eligible to receive ARI planning grant funds, counties must be pre-qualified through the Grant Accountability and Transparency Act Grantee Portal, <u>www.grants.illinois.gov</u>.During pre-qualification, Dun and Bradstreet verifications are performed, including a check of Debarred and Suspended status. The pre-qualification process also includes a financial and administrative risk assessment using an Internal Controls

Questionnaire. All entities found to be ineligible for an award will be notified and informed of corrective action needed for award eligibility.

Cost Sharing or Matching

No matching funds are required.

Indirect Cost Rate

In order to charge indirect costs to a grant, the applicant must have an annually negotiated indirect cost rate agreement (NICRA). The three types of NICRAs include:

a) Federally Negotiated Rate: Applicant organizations that receive direct federal funding may have an indirect cost rate that was negotiated with the Federal Cognizant Agency. Illinois will accept the federally negotiated rate. The organization must provide a copy of the federally NICRA.

b) State Negotiated Rate: The organization must negotiate an indirect cost rate with the State of Illinois if they do not have Federally Negotiated Rate or elect to use the De Minimis Rate. The indirect cost rate proposal must be submitted to the State of Illinois within 90 days of the notice of award.

c) De Minimis Rate: An organization that has never received a Federally Negotiated Rate may elect a de minimis rate of 10% of modified total direct cost (MTDC). Once established, the de minimis rate may be used indefinitely. The State of Illinois must verify the calculation of the MTDC annually in order to accept the de minimis rate.

Reporting

Recipients of ARI funds must submit monthly financial reports, quarterly data reports, and final financial and data reports. Mandatory fiscal and data report templates will be distributed to each grantee for submission soon after the grant start date. Failure to comply with mandatory reporting requirements will cause immediate suspension of funding of this grant, any other grant the applicant has with ARI and the Authority, and possible termination of the grant. If applicable, an annual audit report in accordance with the Part 200 Uniform Requirements must be submitted. Future awards and fund drawdowns may be withheld if reports are delinquent.
