Call to Order and Roll Call

Chairman Sorosky convened the regular meeting of the Illinois Criminal Justice Information Authority and asked Robert Boehmer, the Authority's Secretary and General Counsel, to call the roll.

Approval of the Minutes of the September 5, 2004 Authority Meeting

{*Chairman Sorosky made a motion to approve the minutes of the regular meeting held on September 5, 2004. Mr. Goetten seconded the motion, which passed by unanimous voice vote.*}

Chairman's Remarks

Chairman Sorosky noted that John Stroger, the President of the Cook County Board, will be joining the Authority in January. He then called on Executive Director Lori Levin to provide her report.

Executive Director's Report

Director Levin referred members to the staff activity reports in the mailing and highlighted some things from those reports. She noted that the Authority has won two awards. One award, the Richard Driehaus Foundation Public Innovator Award was awarded for the InfoNet Project, while the other, the Phillip Hoke Award for excellence in research policy and analysis was given for the Authority's publication "Female Delinquents Committed to the Illinois Department of Corrections, A Profile" which was authored by former research assistant Megan Alderden and current research assistant Adriana Perez.

Director Levin welcomed new staff members Kevin Amos, Aaron Gray, Anthony Hunter, Jessica Ashley, Idetta Phillips, Gina Bradley and Lajuana Murphy.

Director Levin reported that most agencies have migrated to the new ALERTS.Net, the Authority continues to roll

out the ALECS.Net client, and all legacy data has not been converted to the PIMSNet System for agency verification and review.

Director Levin said Authority staff have had discussions with Synch Solutions, the software consultants that will be analyzing and assessing the best attributes of ALERTS.Net, ALECS.Net, and PIMSNet software applications, as well as the IWIN software application.

Director Levin reported that the second Elder Abuse conference was held in conjunction with the Department on Aging and the Attorney General's Office. She also noted that the Illinois State Police is rolling out a program to combat financial exploitation of seniors.

Regarding IIJIS, Director Levin reported that we are working on implementing suggestions from the consultants, that we are receiving participation from the judiciary and that we will be having an integration conference in the spring. In addition, she said that we are working on a project with the Department of Mental Health, the Attorney General's Office, and the Sheriffs Association. This project will allow sheriffs to obtain mental health information about inmates in their custody. Director Levin noted that we do have some ADAA money for this project.

She also reported on Motor Vehicle Theft Prevention Council activities, Authority publications, and Research and Analysis Unit activities, which were contained in the memos. She then called on Associate Director Mary Milano to report on the Federal and State Grants Unit.

Associate Director Milano noted that it has been a challenging quarter due to understaffing. She said that we will attempt to fill our staff positions at the line level and supervisory level. Staff is aggressively pursuing programs and processes that will bring resources to bear where they are in shortest supply.

Associate Director Milano highlighted the Federal and State Grants Unit's work on the Local Law Enforcement Block Grants program. She said that we rewrote the process and procedures to simplify the requests for proposals and we sent the forms out three months earlier. We also held information sessions in five locations around the state including Urbana, Alton, Peoria and Chicago and had over 350 officers and representatives of local departments attending. She reported that we added economic need of the local community as an additional consideration in the RFP. She said that we also revised the makeup of the review panels to include greater law enforcement participation.

Associate Director Milano reported that we have worked together with the Illinois State Police to distribute funds for Livescan and are actively providing assistance in underserved communities, attempting to find some ways to help them with match.

Associate Director Milano reported that we are collaborating with the Illinois Department of Corrections on several projects to make sure that they are coordinated and moving ahead. She said that we are supporting the development of the GPS tracking system for released sex offenders, working on the build out of the Pere Marquette drug treatment community for women offenders, and continue to support Sheridan and other facilities.

Associate Director Milano also reported that we have been able to work with the Illinois State Police in developing other initiatives, including creating an elder abuse presence with the provision of \$280,000 for a grant to support investigation and related programming.

Associate Director Milano noted that we received three awards since our last meeting including: VAWA Rural Award, National Forensic Science Foundation Award and the NCHIP award. All of these awards account for close to \$2 million in new funding.

Associate Director Milano commended the FSGU staff for taking on additional grant loads, developing in-house and external training, and collaborating in new ways with other departments. She said that the staff demonstrated the kind of commitment to high standards of public service that of which both the Authority and the people of the state should be proud. Director Levin also commended staff for their hard work.

Director Levin noted that the Associate Director for Research Analysis position has not yet been filled but that we

have a candidate to fill the position of Associate Director for Human Resources. She then called on Robert Boehmer to briefly summarize the new Byrne Memorial Justice Assistance Grant Program.

Mr. Boehmer said the new Justice Assistance Grant Program was an initiative of the Bureau of Justice Assistance (BJA). Since it passed Congress very quickly, the BJA is working on rules for implementation. Mr. Boehmer added that JAG combines Byrne and LLEBG into one program with six purpose areas. Everything that is fundable under Byrne will be fundable under the new program. He noted that we will have to wait for guidelines before we can provide additional details. He noted that of the allocation to the state, 40% of the funds will be distributed to units of local government directly from the BJA, similar to the current LLEBG program. The remaining funds will be distributed by the Authority similar to the way Byrne funds are currently distributed. We would also have to establish a trust fund for the program. He pointed out that the appropriation amount will now result in a overall loss of over one million dollars in Illinois – the Authority would receive around \$14 million for distribution (down from almost \$19 million). The funds made directly available from the BJA to units of local government would significantly increase. He noted that there are still some questions for which we are awaiting answers from the BJA.

Budget Committee Report

Chairman Sorosky reported that Budget Committee met on November 18, 2004. He called on Associate Director Milano to provide the Budget Committee Report.

Associate Director Milano briefly summarized the information that was contained in the meeting mailing. She reported on eleven new Livescan awards, the designation of \$3,552,753 in Byrne 2004 funds to continue 20 multijurisdictional narcotics task forces around the state, funds for three specialized defense initiative programs, VOI/TIS and RSAT funds for Pere Marquette, and funds for the GPS monitoring of sex offenders. She reported that progress continues on the VOI/TIS RFP for a little over \$10 million for construction and expansion of new jails and detention facilities. She said that staff is reviewing final drafts for the RFP and expects to have it finalized January 2005.

Chief Bradford asked whether the Livescan awards were for new machines or replacements. Associate Director Milano noted that some are replacements. She said that in consultation with ISP and others, it has been clear that it will become very expensive not to replace Livescan. She reported that our initial approach was to purchase new equipment first, but we found that older equipment will become more expensive to maintain than to replace. Chief Bradford said that he thought that when the initial awards were made, there was criteria developed that those awards were based on usage and that there were a number of entities that applied but were turned down because their usage levels did not justify the grant at that time. He said that there needs to be come clarification as to why we are replacing machines for departments that already have them while there are still come departments that do not have Livescan. Associate Director Milano said that we are continuing to work down the list, but there are some departments that simply cannot make the match.

Associate Director Milano reported on a request for extension for the VAWA Rural 02 Award. As a result of new federal policy they have decided not to renew rural awards that predate 2003 federal fiscal year. She said that staff has adjusted and extended the performance dates of these three transitional housing grantees to December 31st to maximize utilization of these funds. She also requested that the Authority approve to continue these programs using FY04 Rural funds, which will enable the programs to continue for another 24 months.

{*Mr.* Piland made the motion for the approval and designation of 04 funds, *Mr.* Goetten seconded the motion, which was passed by unanimous voice vote.}

Chairman Sorosky asked the Authority's Chief Fiscal Officer Ted Miller to provide the fiscal report. Mr. Miller reported on the materials in the mailing. He noted that in FY04, we spent 78% of our appropriation. He said that the lapse was due to unfilled personnel vacancies, savings in EDP, and consolidation. He reported that we spent at our historic levels both with the Criminal Justice Information Systems Trust Fund and the federal awards and grants. For fiscal year 05, he said that we expect our general revenue expenditures to be very close to our appropriation because of recent budget cuts, and that we should spend near previous levels for the other funds.

Sheriff Bukowski inquired about the \$300,000 that was transferred from the Criminal Justice Information Systems Trust Fund. Director Levin noted that she informed the Governor's Office of Management and Budget of the user's Authority Minutes December 5, 2003 Page 4 of 5

concern that the funds have not been returned. She said that at one point she understood that the funds would be returned through the Capital Development Bill, but that did not occur because the bill never passed. Mr. Miller noted that the funds came out of the cash balance and were transferred to the General Revenue Fund. Director Levin said that she will continue to raise the concerns of the users.

The Implementation and Impact of Illinois' Sheridan Correctional Center Therapeutic: Year 1

Chairman Sorosky reported that one of the priorities of the Governor is to reduce the recidivism rate that exists among many of our young men who are incarcerated in prison. Substance abuse problems are often related and intertwined with this high recidivism rate. To combat this problem, the correctional center at Sheridan has been reopened and redesignated primarily as a substances abuse center. He said the Authority has been heavily involved in supporting and financing this program. He then called on Dr. David Olson, Authority senior research analyst, and Deanne Benos, assistant director of the Illinois Department of Corrections, to provide an overview of the implementation and impact of the Sheridan Correctional Center.

Ms. Benos thanked the Authority for their support and thanked State's Attorney Devine and Director Trent for providing staff to sit on the planning board for the project. She said that this was one of the first projects the Governor announced when he took office. She said that after a long planning process the project began in January of this year. She indicated that we are now seeing some really positive results.

Ms. Benos said that through the project, we are targeting record recidivism rates at a time when the state is facing record numbers of prison exits. She said that the Authority helped this project with research and identified best practices in order to build the Sheridan model. She indicated that we are now using performance and process evaluations to ensure that we are building a successful model and learning what works within the system to employ on a statewide basis. She said that Sheridan is designed to be the largest state-run drug treatment prison and re-entry program in the United States with a target population of 1,500. The offenders have a significant history of arrests and are subjected to a screening tool for drug addiction. All inmates must be medium security and not murderers, sex offenders, or dual diagnosis offenders.

She reported that IDOC has embarked upon two pilot programs to build community support networks. She said that it is important to have the properly trained community resources in place to treat people and provide the best practices to make them successful. She said that they have targeted two areas – Chicago's west and south sides.

Ms. Benos reported that the Sheridan Project is connecting with the Governor's other significant initiative, which is his Operation Spotlight Parole Reform Plan.

In response to a question from Ms. Mandeltort, Ms. Benos said that they use the Texas Christian University drug assessment tool to assess the level of addiction for the offender coming into the system. At that point, they screen every offender coming to the department for whether or not they are appropriate for Sheridan. It is then a voluntary program. She clarified that IDOC makes the placement decision. In response to another question, she indicated that they are targeting warehousing and food service jobs as well as positions requiring computer skills and the construction industry.

Dr. Olson then displayed a PowerPoint presentation demonstrating some of the early findings for the Sheridan Program. (PowerPoint attached)

Ms. Engel expressed her concern that this same sort of evaluation approach should be used to evaluate the Pere Marquette facility. Ms. Benos noted that Pere Marquette will be the only facility for girls in the state, but that is just a small part of the Governor's female inmate reform initiative.

New Business

Ms. Engel said that she wanted thank Karen Griffiths, for her extraordinary work on Infonet, which received private foundation support from the Driehaus Foundation.

{Chairman Sorosky made a motion to recognize Karen Griffiths' outstanding work with the InfoNet with member programs, and attracting the attention and appreciation of private foundations for the work she has done, seconded by Mr. Piland and adopted by unanimous voice vote}

This memorandum highlights some of the work performed by staff of the Research and Analysis Unit since the Authority's last quarterly meeting.

I. ONGOING ACTIVITIES

A. <u>Publications</u>

Since the last Authority meeting, R & A staff updated the criminal and juvenile justice system profiles for each of the 102 counties in Illinois. The intent of these publications is to put the data that describes each counties criminal and juvenile justice activity into the hands of Illinois' criminal justice policymakers in a useful summary format. In addition to providing policymakers with an overview of activities across the components of the justice system in their county (law enforcement, courts and corrections), the profiles also provide perspective by including trends experienced in counties with similar population sizes.

In addition to the 102 county profiles, the Research and Analysis Unit has also published:

o The Impact of Methamphetamine on Illinois Communities: An Ethnography

B. Office of Public Information

The Office of Public Information (OPI) designs, edits and publishes the Authority's written materials, including: press releases; the agency's annual report; the agency's newsletter called, "The Compiler"; and other publications such as research reports, research bulletins, and evaluation summaries. OPI staff also respond to information and assistance requests from the public, the media, and others.

<u>Press Releases</u>. OPI staff published three (3) press releases since the last Authority meeting. The releases, which are available on the Authority's website, are summarized below:

D. Criminal Justice Information Clearinghouse

The Authority serves as a statewide clearinghouse for statistics and other information about the criminal justice system. During the second quarter (10/1/04- 12/31/04) of SFY05, R&A staff responded to 259 requests from people seeking information — an average of 86 requests per month. Most came from other governmental agencies (32 percent) and the general public (26 percent). Other requests came from private agencies (18 percent), researchers (10 percent), students (7 percent), news media representatives (4 percent), and prison inmates (2 percent). About 20 percent of the requests originated in the Chicago metropolitan area. Thirty-six percent originated in other parts of the state. All other requests for information were received from outside Illinois (26 percent) and unknown areas (18 percent). R&A distributed 28,541 Authority publications during this period. *[TABLE 1 (attached) provides statistics for the latest state fiscal year quarter.]*

E. <u>Web Site Development</u>

R&A staff also contributes toward the continued development of the Authority's Web site (<u>www.icjia.state.il.us</u>). We continue to expand the criminal justice data and information available on the site. New features entitled, *News Digest Summary* and *National Law Enforcement and Corrections Training Center News* have been added to the publications section of the website which provide visitors a variety of Web links to other criminal justice articles and publications. We also continue to actively gather user satisfaction information and other feedback "on-line." The site averaged over 1,569 daily user sessions during this period, and we now have 1,720 registered users of the Authority's email program (called "CJ Dispatch"), which automatically alerts Web site visitors to new information added to the site. Staff continue work on database applications and new software for the site which will allow visitors to download, display and graph data in a variety of formats. [Table 2 (attached) presents website statistics for the latest state fiscal year quarter.]

F. <u>FSGU Support Efforts</u>

Upon request, R&A staff review and comment on proposed program narratives submitted by potential grantees to FSGU. The focus of R&A comments are in the areas of proposed objectives, goals, and performance measures. FSGU staff also request R&A assistance in the development of data reports for proposed programs. During the second quarter of SFY05, R&A staff continue to work with FSGU staff responsible for the VAWA and JAIBG funds to develop data reports for grantees that include the federally mandated performance measures. This effort will allow federal agencies to improve their reporting of the performance of these grant programs at the state and federal level. R&A staff has also assumed responsibility for the computerization of some program performance data and, upon FSGU request, produced program status reports and/or profiles assessing performance over a given period of time. Staff also accompany FSGU staff on grant monitoring site visits and twice this quarter provided training to VOCA grantees on objectives, performance measures and designing data reports to capture that information. *[Table 3 (attached) presents FSGU support statistics for the latest state fiscal year quarter.]*

G. <u>Technical Assistance</u>

R & A staff are frequently called on to provide a variety of technical assistance on extraagency research and evaluation, and program implementation projects. For example, since the last Authority meeting:

- Staff continued to provide limited assistance to several third-party research projects involving studies of individuals' criminal history records;
- Staff continue working with the Illinois Department of Correction's Going Home Program's Reentry Steering Committee;
- Staff provided technical assistance to Illinois' Disproportionate Minority Contact coordinator regarding the collection and interpretation of juvenile justice criminal history record information;
- Staff provided technical assistance to the Illinois Juvenile Detention Alternatives Initiative sites regarding the collection and analysis of data;
- Staff are participating in a working group to advise the Harvard Injury Control Research Center and the Centers for Disease Control on the best way to report homicide data for practical use at the local level;
- Staff continue to collaborate with FSGU staff on the research, development and testing of alternative funding formulas for the allocation of federal monies to Illinois' multijurisdictional drug enforcement units;
- Staff continue to participate with and support the Illinois Attorney General's Methamphetamine Healthcare Advisory Committee's Research Working Group;
- Staff have joined an advisory committee for the Illinois Violent Death Reporting System (IVDRS), a joint project of the City of Chicago Mayor's Office, the city's Department of Public Health, the Illinois Department of Public Health, the Chicago Police Department, and the Cook County Medical Examiner's Office to develop better data regarding violent deaths in Illinois;
- Staff have joined the Illinois Methamphetamine Advisory Panel, a joint project of the Drug Enforcement Administration (DEA), U.S. Attorney's Office, Illinois Attorney General's Office, Illinois State Police, the Illinois Law Enforcement Training and Standards Board, the Illinois Sheriff's Association, the Illinois Association of Chiefs of Police, and the Illinois Drug Officer's Association to discuss the growing threat of methamphetamine abuse in Illinois;
- Staff are participating on the advisory board for the evaluation of the Domestic Violence Helpline, City of Chicago Mayor's Office on Domestic Violence.

H. <u>Deaths in Custody Reporting</u>

The Deaths in Custody Reporting Act (P.L. 106-297, effective 10/13/2000) requires states to compile and report quarterly to the U.S. Department of Justice's Bureau of Justice Statistics (BJS) the number of deaths, and the circumstances surrounding the deaths, of persons in local jails, state prisons, juvenile correctional facilities, and law enforcement custody. Until recently, the information requested by BJS was limited to deaths in local jails, state prisons, and state juvenile facilities. Collection of DICRA information has now been expanded to include deaths that occur while a person is in police custody or in the process of arrest. Information on deaths that occur while a person is in police custody will supplement the annual data on prison inmate deaths that BJS already receives from the Illinois Department of Corrections as part of the National Prisoners Statistics Program and the National Corrections Reporting Program. In March 2004, the Research and Analysis Unit accepted the responsibility for the compilation and quarterly submission of information related to deaths that occur while in police custody or in the process of arrest, in part, due to the Authority's role as Illinois' administering agency for the Violent Offender Incarceration / Truth in Sentencing (VOI/TIS) federal grant program which requires States accepting VOI/TIS funds to participate in the Deaths in Custody reporting program. Beginning July 1, 2004, R&A staff are collecting specific information requested by BJS for all deaths in Illinois that occur while the person is in police custody or in the process of arrest by local, county, and state law enforcement agencies regardless of cause of death. For reporting purposes, the "process of arrest" is defined to include:

- In the physical custody, or under the physical restraint, of law enforcement officers, even if the person was not formally under arrest;
- Any deaths that occur by natural causes, while in the physical custody, or under the physical restraint, of law enforcement officers, even if the person was not formally under arrest;
- Killed by any use of force by law enforcement officers prior to booking;
- At a crime/arrest scene or medical facility prior to booking;
- In transit to or from law enforcement facilities;
- Confined in lockups or booking centers (facilities from which arrestees are usually transferred within 72 hours and not held beyond arraignment.

I. <u>Awards</u>

In January, R&A research analyst Jessica Ashley received the distinguished service award from Attorney General Lisa Madigan for her work as the former coordinator of the Illinois Youth Court Association.

II. CURRENT PROJECTS

A. County Profiles

The short-term project resulted in the production of reports detailing recent and historical criminal and juvenile justice system activity levels across the components of the justice system (i.e., law enforcement, courts, and corrections) for each of Illinois' 102 counties.

B. Balanced and Restorative Justice (BARJ) Implementation Guides

R&A staff are developing a series of profession-specific BARJ implementation guides. Currently being developed are BARJ implementation guides for law enforcement, prosecutors, defense attorneys, judges, and probation officers. These five guides will be published by ICJIA in early Spring 2005. Additional guides for community-based agencies, victim advocates, offender advocates, governmental agencies, youth and schools are planned.

C. Factors that Put Youth at Risk for Delinquency

This is a short-term research project intended to describe Illinois data on "risk factors" associated with juvenile delinquency. Data has been collated at the county and state levels on a number of recognized risk factors. Analysis will be initiated shortly. A Research Bulletin is planned for publication in Spring 2005.

D. Illinois Substance Abuse Monitoring Network

R&A staff, in collaboration with the Department of Human Services' Office on Alcoholism and Substance Abuse established an Illinois Substance Abuse Monitoring Network. This group functions as a special workgroup to facilitate the exchange and analysis of information regarding the nature and extent of drug use, drug abuse, and drug markets in Illinois. The group has met twice and the next meeting is being planned.

E. Criminal History Record Information (CHRI) Audit

The unit's Criminal History Record Information (CHRI) Audit Center is an ADAA-funded in-house effort to continuously examine the accuracy, completeness and timeliness of this information, and to recommend strategies for its improvement.

2004 CHRI Audit. Staff completed site visits and interviews at the sample of sheriff's departments and state's attorney's office around the State. Local agency records have been received. This data collection supports an analysis of the timeliness, accuracy and completeness of electronically reported criminal history information. Audit staff are finalizing the analysis of timeliness of receipt and posting of local arrest data. Preliminary analysis of record completeness and data entry for the accuracy analysis continues. The final audit report is scheduled to be completed in early Spring 2005.

CHRI Improvement Plan. Staff continue to work with the CHRI Improvement Workgroup to develop and submit an updated CHRI Improvement Plan. The plan is necessary to meet funding requirements from the U.S. Department of Justice's Office of Justice Programs relative to national criminal history record improvement grant funding. The workgroup includes representatives from Illinois' local and state criminal justice agencies. The full report is currently undergoing final review.

Juvenile Criminal History Reporting Study. Staff has completed an analysis of the reporting of juvenile arrest, charge, and disposition information mandated under 1998 reforms to the Illinois Juvenile Court Act. A final report has been drafted and is undergoing internal review. Portions of the report will be included in a soon to be published report tentatively titled, "*Juvenile Justice and Risk Factor Data for Illinois: 2003 Annual Report.*"

CHRI Data Mine. The CHRI Data Mine is an electronic connection to criminal history record information housed by the Illinois State Police. Access to CHRI data allows ICJIA to

query the data housed on the computerized criminal history database. Currently, ICJIA research and legal staff are working to develop procedures and policies for data use and sharing, standardized queries, documentation of the data elements, and a publication format for the reporting of aggregate data available in the CHRI Data Mine.

F. Chicago Homicide Dataset Update Project

The R&A Unit maintains a comprehensive database containing information on every homicide that occurred in the City of Chicago between 1965 and 1996. This information is culled from Chicago Police Department files following a long-standing collaborative process developed with the department's Detective Division. Staff is completing an effort to update the dataset with information for the years 1997 through 2000, and will soon begin collecting 2001 data. A variety of research products from this dataset have been developed and an archive version for use by other researchers has been submitted to the University of Michigan's National Criminal Justice Data Archive. Staff also continues to collaborate on various third-party projects involving use of the Chicago Homicide Dataset. Current collaborations include:

- Child homicide victims in Chicago (Kim Vogt, University of Wisconsin)
- An evaluation of arson-associated homicide in Chicago (Dallas Drake)
- Couple age discrepancy and risk of intimate partner homicide (Todd Shackelford, Florida Atlantic University)

G. Statewide Crime Victimization Survey

Growing out of recommendations in the *State Criminal Justice Plan*, staff initiated a state crime victimization survey modeled on the U.S. Department of Justice, Bureau of Justice Statistics' Crime Victimization Survey, and similar efforts in other states. A final report is complete and will be published soon.

H. Managing Offenders with Serious Mental Illness

This collaboration with University of Illinois-Chicago and Dr. James Swartz on a grant from the Robert Woods Johnson Foundation involves our distribution of a series of reports on managing offenders with serious mental illness. The first report, regarding the screening for mental illness among offenders is currently being reviewed and should be available later this winter.

I. Program Evaluation and Research Projects

The R&A Unit pursues an aggressive program evaluation and research agenda through an inhouse ADAA-funded grant program. Current/ongoing evaluation and research efforts supported by the Authority include the following:

1. Evaluation of the Jackson County School-Based Probation Program

Staff from the Center for the Study of Crime, Delinquency and Corrections at Southern Illinois University at Carbondale completed the evaluation of this probation project in September. The report provides an overview of the project and cites a number of issues and considerations that must be addressed by jurisdictions interested in implementing schoolbased probation. A final report has been received and a program summary describing the findings of the evaluation is complete and awaiting final review before publication.

2. <u>Evaluation of Moral Reconation Therapy in the Franklin/Jefferson</u> <u>County Evening Reporting Center Program</u>

Staff from the Public Administration and Policy Analysis Department at Southern Illinois University at Edwardsville completed the evaluation of this probation project in October. The final report contains an overview of the implementation of the projects in the two counties and documents their respective strengths and weaknesses. The report is currently under review.

3. <u>Lake County Domestic Violence Probation Program Evaluation</u>

This is an impact evaluation of a specialized probation program in Lake County focused on domestic violence offenders, and is being carried out by Justice Research Associates (JRA). The project is a follow-up to an implementation evaluation recently completed by JRA and is focusing on the outcome differences between the program participants and a comparison group. A final report is due shortly.

4. <u>Study of Disproportionate Incarceration of Minorities for Drug Crimes</u>

This project is a collaboration between the Authority and Loyola University Chicago, The John Howard Association and TASC, Inc. The study is examining the impact of sentencing laws and practices on the minority community, particularly in response to convictions for drug related crimes. Research bulletins planned include reports on national trends, drug law changes, the nature of addiction and treatment, the Illinois perspective on minority incarceration and policy recommendations. The first report in the series, dealing with the national perspective on the issue, has been published. The second report, describing significant changes in state and federal statutes, has also been submitted and is under review. The third and fourth reports are expected to be completed soon.

5. <u>Reintegration of Gang Offenders in the Community Study</u>

In collaboration with DePaul University's Department of Sociology, the Illinois Department of Corrections, and the Attorney General's Gang Crime Prevention Center, a small-scale, pilot study of the reintegration process is being conducted. The study is largely qualitative, examining how gang & non-gang offenders go about reintegrating into their communities of origin. A final report on the study is due late Spring 2005.

6. <u>Community Mobilization: Best Practices and Lessons Learned</u>

This project involves the development of a series of four research briefs on different aspects of the Attorney General's Gang Crime Prevention Center Community Mobilization Program. The first of four research briefs is available on the topic of resident decision making versus representativeness in the community. The remaining report topics include the evolution of program implementation, resident involvement/coalition building and integration into the surrounding community. These reports are available and staff have completed a summary report that is awaiting final review prior to publication.

7. <u>Returning Home: Understanding the Challenges of Prisoner Reentry in</u> <u>Illinois.</u>

This project will be carried out by The Urban Institute. It will involve development of a policy briefing synthesizing findings from four waves of prisoner interviews, interviews with family members, focus groups with residents, and interviews with stakeholders to present the first systematic understanding of the process of prisoner reentry and the specific issues and challenges associated with reentry in Chicago. The report will be due in April 2005. Past reports, available on the Urban Institute's website (www.ui.urban.org), include: A Portrait of Prisoner Reentry in Illinois, and a research brief entitled, Illinois Prisoners' Reflections on Returning Home.

8. <u>Illinois Going Home Program Evaluation</u>

An implementation and preliminary impact evaluation of the Illinois Going Home Program is currently being conducted by the University of Chicago. The program is a major offender reentry effort funded through a partnership of contributing federal agencies and in concert with a number of Chicago-area government, community and faith-based organizations. The evaluation will determine if the program was implemented as designed, how it worked in the field and the effectiveness of the program. Evaluators recently completed a one-year interim report in September. This report identified a number of recommendations for increasing enrollment that Going Home staff are currently implementing.

9. <u>Circuit Court of Cook County, Department of Social Service, Domestic</u> <u>Violence Intervention Program</u>

This project is being conducted by University of Illinois at Chicago under the direction of Larry Bennet and the West Side Domestic Abuse Project (WSDAP) in collaboration with the Social Service Department of the Circuit Court of Cook County. In 1999, UIC and WSDAP developed an assessment tool for batterers aimed to increase the safety of victims and improve the ability of staff to identify men who are at high risk and intervene to reduce their risk by assertive case management. This project will use existing Cook County PROMIS data and supplemental data collected from case records on men participating in the Domestic Violence Intervention Program. Researchers will be able to collect longitudinal data on predictors of attrition and outcomes for men who batter that can be used by policy makers and staff to improve intervention services. Researchers will also be able to contribute important information to the larger criminal justice and violence against women communities about the effectiveness of justice-based intervention with batterers. Researchers are now examining data on nearly 11,000 male domestic violence clients. A final report on this project is due this winter.

10. <u>An Evaluation of the Chicago Police Department's CLEAR Initiative –</u> <u>Phase II</u>

The continued evaluation of CLEAR, the Citizen and Law Enforcement Analysis and Reporting project, is scheduled to continue with a grant to the University of Illinois at Chicago. CLEAR is a major initiative of the Chicago Police Department to integrate information systems and processes within the department. The continued evaluation will focus on the efforts aimed at the introduction of high-priority applications, and the resources and processes needed to develop and implement the major components of CLEAR. A full draft report was made available to ICJIA staff in December 2004 and a final report is expected by the end of February 2005.

11. Analysis of Datasets Maintained/Available Through the Authority

R&A staff have collaborated with external researchers on two projects that will focus on the analysis of InfoNet data. InfoNet is a database that maintains information from victim service providers and agencies:

- The first project, under the direction of Loyola University's Dr. Susan Grossman and Dr. Marta Lundy, focuses on the analysis of sexual abuse data and will provide much needed information on those that seek help and services for sexual assault in Illinois. The research questions focus on the adult survivors and victims of sexual assault and abuse and will detail the following: basic demographics and income sources, relationship between the client and abuser, characteristics of the abuser, issues and circumstances of the abuse/assault, special needs, referral sources, experience with medical services, intensity and duration of support and social services, and legal actions taken in response to the abuse/assault. In addition, this project will generate a template for victim service centers to use so that they can complete a center-level analysis based on the study's statewide and regional analyses. This report is currently under review.
- An additional project under the direction of Dr. Karla Fischer will focus on information on those that seek help for domestic violence in Illinois. The study will include a profile of victims, offenders and children, and the types of services they seek and ultimately receive. The profiles will be generated on three levels—the individual service providing agencies, communities and the state. The findings will aid in identifying underserved populations and unmet social service needs in the area of domestic violence services. The draft report has been received and is currently under review.

Also, a Request for Proposals (RFP) was developed to seek proposals for the analysis of other datasets currently available through the Authority. Three small-scale research projects seek to answer research questions on data from the Illinois Crime Victimization Survey and the 2000 Probation Outcome Study.

- Analysis of Crime Victimization Data Rate and Nature of Victimization and Utilization of Resources by Southern Illinois University Carbondale. Dr. Amanda Mathias Humphrey will conduct a study of the CVS data to determine the level of victimization in Illinois, differences in victimization, reporting practices and demographic differences, use of services and demographic differences in service utilization.
- Analysis of Crime Victimization Data Violent Crime and Victim's Gender by Dr. Callie Rennison of the University of Missouri St. Louis. This analysis will address whether individual and family level correlates of nonfatal victimization differ by gender, whether these correlates differ by type of nonfatal violent crime and whether they differ depending on the victim and offender relationship.

• Analysis of Drug Use, Treatment and Probation Outcomes by Dr. Beth Hueber of the University of Missouri at St. Louis. This project will identify the characteristics of drug-involved probationers, the prevalence of participation in treatment and the effect of treatment on probation outcomes.

12. <u>Safe Haven Domestic Violence Program Evaluation Project</u>

Staff are currently evaluating the Chicago Safe Havens demonstration site, a project funded under the Supervised Visitation and Safe Exchange Grant Program. The Safe Havens Program was established by the Violence Against Women Act of 2000 to provide an opportunity for communities to support supervised visitation and safe exchange of children, by and between parents, in situations involving domestic violence, child abuse, sexual assault, or stalking. The project enables custodial parents to drop off their children for court ordered visits and exchanges, without having to face the non-custodial parent. The visit with the non-custodial parent takes place at a visitation center, with social service staff observing and monitoring the visit. The purpose of the supervised visitation program is to enable custodial parents to comply with court ordered visitation, without having to fear that they or their children will be re-victimized. ICJIA research staff are serving as local evaluators for the demonstration initiative.

13. <u>Criminal Justice Agencies Needs Assessment Survey Project</u>

Orbis Partners has been selected to conduct a criminal justice needs assessment in Illinois. The primary purpose of this study is to supply information that will demonstrate the needs of criminal justice organizations, and identify areas that need improvement. The information will also be used to guide decision-making regarding where to best allocate resources. A secondary purpose of this study is to provide information that outlines if, and how, the needs of criminal justice organizations have changed over time by comparing the data collected as part of this study to the results of a needs assessment survey conducted in 1996. Major components of the criminal justice system will be surveyed on topics such as workload demands, training needs, staff retention, information systems and programming. A project kickoff meeting between R&A staff and Orbis Partners was held on November 16, 2004. Data collection is expected to begin in March of 2005. The assessment and final report will be completed by the end of calendar year 2005.

14. <u>Chicago Public School Peer Jury Program Evaluation Project</u>

Florida Atlantic University has been selected to evaluate the Chicago Public School's Peer Jury Program and its operation and development during the 2003/2004 and 2005/2005 school year. The study will focus on three schools that implemented the program, but will also involve the collection of some general descriptive data pertaining to the program as a whole. The evaluation will assist program practitioners and technical support staff in improving the program, and assist Chicago Public School's administrative staff in making future decisions regarding the program. In addition, the study will contribute to bodies of research examining restorative justice and programming for minors.

15. <u>Evaluation of IDOC's Sheridan Correctional Center Therapeutic</u> <u>Community Program</u>

Research and Analysis staff are participating in the development and evaluation of the recently opened Sheridan Correctional Center. Open since January, Sheridan operates as a fully dedicated therapeutic community for inmates in need of substance abuse treatment. Sheridan will provide all participants access to a wide array of services, including substance abuse treatment, education and vocational programming. The program will also prepare inmates for release into the community and provide access to services and support following their release. In addition to Authority staff, a number of organizations assisted in the development of Sheridan, including treatment agencies, governmental agencies, community organizations, national experts and inmates. The prison will operate at a capacity of 1,300 inmates and include males that are projected to serve between 6 and 30 months, be eligible for placement in a medium security facility and be in need of substance abuse treatment. Sheridan is the largest treatment prison in the county. The evaluation of Sheridan will be a collaborative effort between the Authority and the Illinois Department of Corrections, and will be guided by an Evaluation Advisory Committee. The process and impact evaluation will involve extensive quantitative data collection and qualitative information from focus groups and interviews with staff and participants. The evaluation will seek to measure changes in participant attitudes, beliefs and psychological functioning, in addition to participants' preparedness for release. The study will also examine the extent and nature of institutional violations and measures of recidivism after release. Employment and access to services will also be studied. A summary of the project was recently released as a Program Evaluation Summary report.

16. <u>The Impact of Methamphetamine on Illinois Communities: An</u> <u>Ethnography</u>

A final report by Dr. Ralph Weisheit of Illinois State University was submitted in October. The report documents site visits and interviews that examine the effects of methamphetamine in Edgar and Clark counties. The report address several research questions, including: What is the impact of methamphetamine on rural communities?; What resources in rural communities can be brought to bear on the problem of methamphetamine?; and, What additional resources might facilitate an effective response to the problem? The report was made available on the ICJIA website in December of 2004.

17. Evaluation of Redeploy Illinois Sites

A Request for Proposals (RFP) was issued in November for the evaluation of two Redeploy Illinois sites. The first site, in Macon County, provides a series of services and treatments in an effort to keep juveniles in the community and out of the Illinois Department of Corrections. The second site, in the 2nd Judicial Circuit, also employs treatment and includes Multi-Systemic Therapy, Functional Family Therapy and Aggression Replacement Training to keep youth in the community. Powered Performance, a Wheaton, IL based research and consulting firm was awarded the contract to evaluate both Redeploy sites. Negotiations are underway and the project is expected to officially start in early March.

J. <u>Externally-Funded Research and Evaluation Projects</u>

R&A staff have been successful in the pursuit of external discretionary grants to support research and evaluation efforts. Several current projects are or were supported by such grants:

1. <u>NIJ Chicago Women's Health Risk Study (CWHRS) Follow-Up</u>

The Chicago Women's Health Risk Project is a continuing collaboration of Chicago medical, public health, and criminal justice agencies, and domestic violence experts to identify factors that indicate a significant danger of life-threatening injury or death in situations of intimate partner violence. Collaborating agencies include the Chicago Department of Public Health, Erie Family Health Center, Cook County Hospital, Chicago Mayor's Office on Domestic Violence, Cook County Medical Examiner's Office, Chicago Police Department and the Authority. Project research included detailed interviews with abused women sampled as they entered a hospital, clinic, or health center for treatment, as well as interviews with people who knew victims of intimate partner homicide. By comparing data on abused women with similar data on people who have been killed by an intimate partner, the project helps agencies develop collaborative ways to identify and respond to potentially life-threatening intimate violence situations. A follow-up study looked at the effects of community capacity to determine whether the violence stopped or declined in the abused women's neighborhoods. The research provides vital information to beat officers, clinical staff, and other decision-makers in the field. The Chicago Women's Health Risk Project was supported with grants from the National Institute of Justice, the Authority, and other agencies. A number of reports, journal articles and other publications have been developed from the research. Staff continues to be solicited for presentations and briefings on the research and project tools, and data continue to be requested for use by other researchers. Most recently, Carolyn Rebecca Block was asked to present relevant findings as part of in-service training efforts in the Chicago Police Department. Current collaborations on reports from CWHRS include:

Staff also continues to operate The CWHRS Forum, a listserv focused on research and policy issues related to the risk of intimate partner homicide. It allows members to easily share information and technical assistance.

2. <u>IJJC Study of Disproportionate Minority Representation in the Cook</u> <u>County Juvenile Justice System</u>

This project is funded by the Illinois Juvenile Justice Commission (IJJC) utilizing U.S. Department of Justice, Office of Juvenile Justice and Delinquency Prevention (OJJDP) funds. It is a study of disproportionate minority representation among juveniles in the Cook County Juvenile Justice System. Staff has completed the collection and analysis of aggregate data from various juvenile justice system contact points, and has presented a draft of those findings at a meeting of the Illinois Juvenile Justice Commission. Staff collected case-level data on a sample of juveniles to measure the possible influence of specific factors on decisions made as the juveniles are processed through the system. A final report was approved by the Commission and added to the Authority's website. A *Research Bulletin* drawing from these findings is also planned.

III. GRANT PROPOSALS

R&A staff routinely pursue discretionary grants to support data collection, research, and evaluation activities. Frequently these projects involve collaborations with universities and/or other criminal justice agencies.

- 1. *Awarded* Supported by a \$68,000 grant from the Illinois Juvenile Justice Commission through the Illinois Department of Human Services, R&A staff are producing a data report on Illinois' Juvenile Justice System.
- 2. *Submitted* Staff collaborated with Dr. Kimberly A. Vogt of the University of Wisconsin on an application to the National Institute of Justice for a grant to support a study of homicides of infants and toddlers.
- 3. *Submitted* Staff collaborated with JRSA on an application to the National Institute of Justice for a grant to support a multi-state study of the impact of methamphetamine on local criminal justice and social service systems.
- 4. *Submitted* Staff collaborated with the Administrative Office of the Illinois Courts on a grant from the National Institute of Corrections to provide research support for the AOIC's Evidence-Based Practices in Probation project. The initial grant proposal was accepted with a request for revisions to address specific questions of reviewers and to incorporate program activities that utilize an additional \$100,000 being offered to the Research and Analysis Unit.
- 5. *Under development* Staff is consulting with JRSA on the submission of study proposals to the National Institute on Drug Abuse (NIDA) that may involve several other states in an examination of the impact of methamphetamine abuse on local criminal justice systems.

IV. ONGOING STAFF DEVELOPMENT/TRAINING

- Staff continues to conduct and/or take part in a variety of staff development and training programs and projects. These include: (a) observations/site visits to several key criminal justice agencies; (b) peer review process for project development and pre-publication; (c) partnerships with the academic community; (d) development of specific training classes including ArcView mapping, multivariate statistical analysis, basic SPSS use, data availability in criminal justice, among other topics; and (e) human subject research issues/concerns and practices.
- Several R&A staff persons are actively pursuing advanced academic degrees in graduate programs and post-graduate programs. Some staff also serve as adjunct faculty in criminal justice and other social science programs.

The staff assigned to the Federal and State Grants Unit (FSGU) performed the following activities during the period of November 1, 2004, to January 31, 2005. During this period, FSGU headcount remained at 19, as there are vacancies that have yet to be filled. Further hiring is anticipated.

Grant Activities

During the reporting period FSGU staff monitored 525 grants, representing approximately \$11,290,849 in grant funds. Monitoring included the following:

- Reviewing (1,351) monthly or quarterly reports: (669) data and (682) fiscal;
- Initiating disbursement of funds requested by grantees;
- Conducting (over 30) site visits;
- Processing budget revisions and/or amendments to existing agreements;
- Reviewing requests for proposals (RFPs) drafted by grantees and proposed subcontracts between grantees and other service providers or vendors; and
- Providing technical assistance to grantees (approximately 1,100 times). This included telephonic, e-mail, and on site contacts with grantees that requested assistance regarding issues relating to their grant(s). Staff also received communications from non-grantees regarding types of grants available through the federal government, and/or how to complete forms for federal grants.

During this reporting period, FSGU staff processed 62 new agreements (grants), representing \$7,117,515 in grant funds. Processing of a new agreement includes:

- Negotiating the program narrative, budget, and budget narrative with the grantee;
- Processing the grant proposal for in-house legal, fiscal, and research and analysis reviews and comments;
- Making necessary changes and forwarding the agreement to the grantee for signature;
- Once returned, processing the agreement through the Office of General Counsel for the executive director's signature, and, when signed, returning a fully executed copy to the grantee as well as other contacts; and

• Initiating an obligation and disbursing any initial funds that are requested. Administrative Activities

Meetings

During the reporting period, FSGU staff have planned for and/or staffed 5 meetings:

- Two Budget Committee meetings were held; one on November 18, 2004, and one on December 21, 2004.
- Planning began on a Budget Committee meeting to be held on February 10, 2005.
- Staff held one Motor Vehicle Theft Prevention Council Quarterly meeting in November 2004.
- Staff held one Illinois Motor Vehicle Theft Prevention Council (IMVTPC) Grant Review Committee meeting on January 2005.

Meeting preparation often involves coordination with other Authority units such as Research and Analysis and the Office of Administrative Services, and often includes logistics coordination and production, assembly, and mailing of materials.

Training Sessions Conducted

- Staff planned and prepared for a VAWA Rural New Grantee orientation that was held at the Authority's offices in Chicago, Illinois on January 24-26.
- Staff conducted an Elder Abuse training in Champaign, Illinois on November 5, 2004. Over 50 law enforcement officers, prosecutors, and victim service providers attended.
- Staff held two trainings for VOCA grantees; one in Chicago, Illinois on January 19, 2005 with approximately 11 grantees in attendance, and one in Mount Vernon, Illinois on January 21, 2005 with approximately 7 grantees in attendance.

Conferences Attended

Two staff members attended a VAWA Rural technical assistance conference in Las Vegas, Nevada on January 25-27.

Other Activities

- In support of the Authority's Strategic Plan, staff continues to prioritize projects and activities as well as develop strategies to best incorporate the Authority's Action Plan initiatives into unit operations.
- During the reporting period, FSGU continued to operate without a full staff. Executive staff is pursuing the hiring process with expectations of returning the unit to full strength. On an individual basis, staff members have continued to handle increased grant loads, train the new employees, and perform other responsibilities, pending the filling of vacant positions.

- Staff continually updates and upgrades Attachment A's, fact sheets (program/fund information sheets), funding charts, and other items on the Authority's Internet and Intranet sites.
- Staff is examining ways to improve the public's access via the Internet to information relating to programs that receive funds from the Authority and to information about the individual grantees. This is part of an on-going process aimed at making the Authority's activities more open and transparent to the general public.
- Staff is continuing to work and meet with the Authority's Research and Analysis Unit as well as other state and local agencies, such as the Administrative Office of the Illinois Courts, jail-based mental health services, community-based transitional services for female offenders, and juvenile reporting centers to advance common goals and projects.
- Staff is working closely with Fiscal Management staff to close out the ADAA Federal Fiscal Years 1995 and 1996 and NCHIP Federal Fiscal Years 1995 through 1999.
- Staff continues to be involved in post-BARJ Summit activities, including the Illinois BARJ initiative. Staff actively engaged in planning a new conference called *Juvenile Justice in Illinois: Implementing Restorative Practices in Your Community.* The conference will be held in Springfield, Illinois on March 2-4, 2005.
- Staff updated and streamlined the LLEBG application process and format. The FFY04 request for proposals, published in October, attracted 426 proposals requesting over \$7 million in funding. The proposals were reviewed in January and initial funding recommendations were made to the Budget Committee at its February 10, 2005 meeting.
- Staff continued a series of internal trainings with trainings being held on a weekly basis.
- Staff planned and implemented a VOI/TIS Local Jail Construction Request For Proposals. This process began in January and is continuing.
- In December 2004 staff met with the Director of the Non-Life Insurance Institute of Japan to brief him on how the IMVTPC works to reduce auto theft in Illinois. Due to an increase in auto theft in Japan they are seeking input from other countries on their attempts to reduce auto theft.
- Staff completed coordination with the Illinois Department of Insurance to obtain the names of all insurance companies that wrote comprehensive auto insurance policies in Illinois in 2004. We have also sent each of the 142 companies their annual notice that their payments to the IMVTPC Trust Fund are due by April 1, 2005.
- Staff provided information relating to FSGU and Motor Vehicle activities to the Office of Public Information for inclusion in the ICJIA Annual Report.

The following highlights the work performed by Information Systems Unit since the last Authority meeting.

The InfoNet System

One hundred and one domestic violence and sexual assault programs and 12 child advocacy centers currently access InfoNet from more than 150 sites throughout the State. Since the Authority last met, the InfoNet team continued to improve the efficiency and performance of the system for current users. Some specific accomplishments during the past quarter follow.

During the report period, programming staff ported all ASP Web pages to ASP.Net. This work was completed in order to improve application performance and reduce the application code base, thus minimizing maintenance. In addition, staff continued to provide technical assistance and training to InfoNet users. Two new user trainings were conducted – one in Springfield for child advocacy centers and one in Chicago for sexual assault centers -- and two User Group meetings were convened in Bloomington. In addition, staff provided a one-day workshop for sexual assault programs in Springfield on January 20, 2005. The morning session showed users how to use InfoNet to track and report grant-specific information and the afternoon session demonstrated how to use the data collected in InfoNet for case management, program development, and reporting.

The Authority's Web Page

We continue to expand the criminal justice data and information available on the site. New features entitled, *News Digest Summary* and *National Law Enforcement and Corrections Training Center News* have been added to the publications section of the website. In addition, the 102 Illinois *County Profiles* have been updated and made available for download. We also continue to actively gather user satisfaction information and other feedback "on-line." The site averaged over 1,550 daily user sessions during this period, and we now have 1,721 registered users of the Authority's email notification program (called "CJ Dispatch"), which automatically alerts Web site visitors to new information added to the site. Staff continues work on database applications and new software for the site which will allow visitors to download, display and graph data in a variety of formats.

Customer Service Activities in support of ALERTS, PIMS, ALECS and InfoNet

ISU Customer Service staff continues to conduct training, answer calls for service and provide support for customers of the Authority's systems. There were a total of 1,070 calls for service from November 16, 2004 through February 14, 2005. Customer Service also provides technical support via telephone and e-mail for users of the InfoNet database system.

Customer Service is in the final phases of migrating ALERTS and ALECS agencies from the legacy HP3000 platform to the Microsoft browser-based platform. The PIMSNet rollout, in addition to the ALERTSNet rollout, is also moving along and agencies continue to be trained and moved over to the new SQL platform.

Improvements to the Authority's Networking Infrastructure

Our efforts continue to improve the Illinois Criminal Justice Information Authority network infrastructure. We are proud to announce our first major improvement, the installation of new, redundant Checkpoint Firewalls and the DELL server platforms they run on. This up-to-date firewall protection keeps our network secure and reliable. In addition, it provides remote client VPN support as well as a point-to-point VPN gateway for remote users and offices. The intent is to provide remote support for the ISU staff to monitor systems and the network.

In addition, we have isolated the ICJIA network from the server resource network. Previously, ICJIA traffic would have to traverse the server resource network to get to the Internet, the State frame or the Cook County WAN. This has decreased server resource bandwidth use.

The list of hardware replacement has started with upgrading our obsolete HP servers to Dell PowerEdge 2650 and 6650 servers. Since our new servers are able to provide 1GB speed we have begun replacing our cat5 network cables to cat6 to accommodate the speed.

Finally, we also are in the process of upgrading our network from Windows NT environment to Windows 2000 with Active Directory schema. This includes upgrades of our email server to Exchange 2000 with webmail services and our DNS server to Windows 2000 Advanced server.

The Authority's Information Systems for Law Enforcement

- ALERTSNet: To date the Authority has migrated most of the ALERTS agencies that do not have a CAD interface to the new SQL host for the ALERTS network. In the coming weeks we will be completing the rollout of the new ALERTS host for all agencies, including those with a CAD interface. The Authority is continuing development of a browser-based mobile data client for the ALERTS network. The new ALERTSNet backbone is now supporting the direct interface of additional CAD vendors.
- ALECSNet: The Authority continues to rollout the new ALECSNet client. ALECSNet is a browser-based system using standard Microsoft applications. The Authority has successfully implemented ALECS at over 70 sites to date. The Authority will continue the rollout of the new application in coordination with the ALERTSNet rollout.
- **PIMSNet:** All legacy data has now been converted to the Test PIMSNet system for agency verification and review. Training of agency personnel on the new browser-based SQL PIMSNet system continues. The migration of legacy PIMS agencies will proceed at its' current pace. The projected date, for the removal of all antiquated HP3000 hardware, is May 1st.

Other Activities

Synch Solutions, a software consulting firm, made an IWIN/ALERTS convergence presentation to the ALERTS and PIMS Board members. ISU is currently awaiting a response from the board members.

Since the last Authority meeting, the following progress has been made on the Illinois Integrated Justice Information Systems (IIJIS) Project:

- The IIJIS Planning and Policy Committee created work groups to develop business plans for meeting the justice integration needs identified in the IIJIS Strategic Plan. The work groups are addressing three high-priority areas:
 - development of a standard police report as a preliminary step toward creating an incident reporting process in Illinois;
 - improving the quality of orders of protection and warrant information contained in the Law Enforcement Agency Data System (LEADS); and
 - analyzing the manner in which arrest booking information is collected and managed in order to improve criminal history record information.

For each issue area, the business case document will contain a description of current practices and procedures, detailed accounts of how the current process fails to meet the needs of criminal justice practitioners and decision-makers, alternative solutions being considered, programmatic and economic benefits as well as risks and other costs associated with those alternatives, the consequences of no action being taken, and whether the solution is interdependent on other integration business requirements being addressed. These business cases will later become the foundation for an IIJIS Tactical Plan that lays out a project implementation schedule.

The Orders of Protection/Warrant Work Group has begun collecting survey responses from sheriffs', police, and court clerks' agencies; and has created workflow diagrams to document information gaps and other issues.

- An IIJIS Summit is being planned for June 9, 2005, at the Hilton Lisle/Naperville. The objectives of the Summit are to:
 - introduce and educate the stakeholders of the Illinois justice community about integration efforts underway;
 - recruit champions who will be committed to advocating and supporting integrated justice in their respective jurisdictions;
 - provide strategic planning guidelines to counties;
 - identify and garner support for IIJIS from legislators and other decision-makers; and
 - establish and promote information sharing partnerships among justice, public safety, and homeland security communities.

The Summit program will include sessions covering the purposes of justice integration, ongoing integration efforts in Illinois, privacy concerns in the sharing of justice information, and strategic planning. Two sets of panel discussions are also being planned.

• IIJIS staff has prepared the first draft of the 2005 Annual Report to the Governor and the General Assembly. The report will focus largely on the IJIS Institute/SEARCH recommendations for the project, and the response by the Board and staff to those recommendations. It is due on April 1, 2005.




