## Victims of Crime Act Competitive Funding Opportunities

## Background

The Victims of Crime Act (VOCA) Victim Assistance Formula Grant Program, administered by the Office for Victims of Crime and funded by the Crime Victims Fund, provides federal formula block grants to states and territories on an annual basis.

VOCA funding must be used to support direct services to victims of crime designed to respond to victims' emotional, psychological and physical needs, assist victims in stabilizing their lives, restore a measure of safety for victims, or assist victims in understanding and , participating in the criminal justice system. VOCA requires a minimum of 10 percent of a State's annual VOCA grant to be allocated to each of the following program areas: domestic violence, sexual assault, child abuse and underserved victims of violent crime (as defined by the State). <u>VOCA funds may not be used to supplant or replace state and local funds that would otherwise be available for crime victim services and must be used to develop new projects or expand existing projects.</u>

ICJIA recently completed a statewide assessment of victim needs and services in Illinois. The report was presented to the ICJIA Ad Hoc Victim Services Committee for consultation and coordination with other state agencies. The final report's recommendations were approved by ICJIA Board in January 2017. These recommendations outline a comprehensive plan to address victims' needs in Illinois and will be reflected in ICJIA's VOCA funding opportunities as appropriate. ## Federal and State Requirements of ICJIA's Grantmaking Process

ICJIA will administer VOCA funds in accordance with the following:

- VOCA Statute, 42 USC 10603, the VOCA Victim Assistance Program Final Guidelines and Rule, guidance issued by the Office for Victims of Crime, the Department of Justice Grants Financial Guide, government-wide grant rules and all other applicable federal laws.
- State law, including the 2014 Illinois Grant Accountability and Transparency Act which requires a rigorous use of competitive notices of funding opportunity.
- ICJIA's administrative rules.

ICJIA anticipates the release of several competitive funding opportunities in 2017 and 2018. The chart below provides general guidance on strategic focus, release and grant timing. ICJIA cannot provide more detail regarding upcoming funding opportunities as doing so may disqualify potential applicants from funding.

Each funding opportunity will be posted on the ICJIA website and announced via our listserve, Twitter and Facebook pages. Please connect with this resources if you haven't already done so. In addition, it will be posted in the Daily Register.

In addition, there are several steps a potential applicant should take to prepare for a solicitation:

• Apply for pre-qualification through the Grant Accountability and Transparency Act (GATA) Grantee Portal, <u>www.grants.illinois.gov</u>. During pre-qualification, Dun and Bradstreet verifications are performed, including a check of Debarred and Suspended status and good standing with the Illinois Secretary of State.

The pre-qualification process also includes a financial and administrative risk assessment using an Internal Controls Questionnaire (ICQ). <u>The ICQ must be</u> submitted through the GATA portal and approved by a State cognizant agency by the date an application is received at ICJIA or any other state agency. All applications will be pre-screened for completeness and ICQ approval. Applications from agencies that do not have an approved ICQ will not be reviewed.
