Illinois Integrated Justice Information System Homeland Security Workgroup Meeting March 15, 2004

- **Meeting Overview:** Chairman Bouche discussed the purpose of the Homeland Security Workgroups. Our focus is on improving information and communication capabilities to anticipate, deter, and respond to homeland security threats. We will break into the following two workgroups to develop scenarios for information sharing: 1) Prevention and 2) Response. We need to determine the type of homeland security event(s) we will focus our scenario on and then describe it.
- **History of IIJIS:** Chairman Bouche discussed the IIJIS Strategic Plan, endorsement of the plan and creation of the IIJIS Implementation Board by Governor Blagojevich, and focus of the IIJIS Subcommittees. - **Homeland Security Scenario:** Chairman Bouche discussed the handout “*Scenario for Information Sharing in Illinois*”. The IIJIS Planning Committee created this scenario for the adult

arrest. We will use the same format to build the Homeland Security Scenarios. The scenario planning methods will identify the future functions, range of information exchanges and interactions needed among public safety and private partners to prevent and respond to a Homeland Security event. Once developed, current and planned technology for public safety information and communication systems can be validated against Illinois' scenario to identify the gaps that exist today between justice agencies, emergency responders, medical personnel, etc.

- **Homeland Security ConOps:** The handout "*Illinois Integrated Justice Information Systems (IIJIS), Concept of Operations for an Illinois Homeland Security Scenario*" provides the overview, purpose, scope, method, participating agencies, and expected outcomes of the Homeland Security Scenario. It was suggested that we need more concrete examples of outcomes. Carol Gibbs discussed more concrete examples of those outcomes.
- **Types of Homeland Security Attacks/Incidents:** The committee identified the attached "types of threats/incidents" and "types of targets". We will review this list at the next meeting and determine what type of Homeland Security event the scenario will focus on.
- **Committee Structure:** Chairman Bouche said we need volunteers to provide leadership and participation on the Response and Prevention Workgroups. We need participation from STIC experts, the ITTF, IEMA, railway police/security, private security, etc. Committee members were asked to send the names of additional participants to Carol Cates at: carol_cates@isp.state.il.us or by phone 312/745-5281.
- **Next Steps/Assignments:** Chairman Bouche asked committee members to reach out to other participants. Members were also asked to email Carol Cates any tabletop exercise reports or other relevant summaries of Homeland Security incidents or exercises. At the next meeting, we will identify the type of Homeland Security incident we will focus on and then break into two workgroups to begin development of the Scenarios for Prevention and Response to a Homeland Security Event.
