

Illinois Motor Vehicle Theft Prevention Council February 19, 2014 – 10:00 A.M. Illinois Criminal Justice Information Authority 300 W. Adams Street, Suite 200 Chicago, IL 60606

The Illinois Motor Vehicle Theft Prevention Council held its first quarter 2014 Council meeting at 10:00 A.M. on February 19, 2014 in Chicago, Illinois.

CALL TO ORDER AND ROLL CALL

Vice-Chairman Brad Demuzio chaired the Council meeting and called the meeting to order. Junaid Afeef, Illinois Criminal Justice Information Authority Acting Deputy General Counsel, called roll.

A quorum of the members was present.

MINUTES OF NOVEMBER 6, 2013 COUNCIL MEETING

Vice-Chair Demuzio asked the Council members if they had any questions, comments, and/or edits with regard to the November 6, 2013 Council meeting minutes. There were no questions, comments, or edits. Mr. Johnson moved to approve the 11/6/13 Council meeting minutes, and Mr. Cholewin seconded the motion. The motion was approved unanimously.

PROGRAM DIRECTOR'S REPORT

Vice-Chair Demuzio asked Program Director Greg Stevens to present his report. Mr. Stevens reported as follows:

Trust Fund Reports – A balance of \$2,502,955 remains in the trust fund at the end of 2013. Mr. Stevens noted that there is a projected Trust Fund balance of \$1,994,155 at the end of 2014. Mr. Stevens stated that a preliminary review of the grantee reports suggests a lapse of \$50,000 in 2013.

Program Fleet Summary – Mr. Stevens made a brief reference to the Program Fleet Summary in the Council members' materials.

Staff Activities – Mr. Stevens made a brief reference to a memo in the Council

members' materials regarding staff activities. He noted several meetings attended in the past several months by Council staff. Mr. Stevens also commented on the directors' training held late last year by MEATTF. He stated that the training went well, and also that it was well received by those who attended.

Mr. Stevens noted that letters to insurance companies in Illinois had gone out, and that last year the Council received a record dollar amount in required insurance company contributions to the MVTPC Trust Fund.

GRANT REVIEW COMMITTEE REPORT

Vice-Chair Demuzio noted that the Grant Review Committee meeting for January 16, 2014 was cancelled due to a lack of agenda items. He further noted that GRC Committee Chair Terry Lemming retired from the Illinois State Police on December 31, 2013. He noted that Council Chairman Hiram Grau appointed Lt. Col. Todd Kilby of the Illinois State Police as the new Chair of the GRC.

QUARTERLY ACTIVITY SUMMARY

Vice-Chair Demuzio asked the Council members to reference the Council's most recent Quarterly Activity Summary prepared by the Illinois State Police, Motor Vehicle Theft Intelligence Clearinghouse. He asked if any Council members had comments or questions regarding the summary. Mr. Stevens noted that this summary is normally in the GRC meeting materials, but since there was not a GRC meeting in January 2014, this important document was included with the Council materials.

PROGRAM PRESENTATION

Secretary of State Audit Team Program

Vice-Chair Demuzio called upon Lt. Tom Chandler of the Secretary of State Police to present a summary of progress of the Secretary of State Audit Team Program over the last twelve months. He noted that a written program profile was in the Council members' materials behind Tab E. Vice-Chair Demuzio also noted that several members of the SOS Audit Team were in attendance at this Council meeting.

Lt. Chandler introduced himself. He gave a brief background about himself, and the he gave an overview of the program.

RESOLUTION OF COMMENDATION

Vic-Chair Demuzio next asked the Council members to review a Resolution of Commendation for Lieutenant Colonel Terry Lemming. He stated that Lt. Col. Lemming retired from the Illinois State Police and that he served as the Chairman of the Grant Review Committee from August 2012 to December 31, 2013, and that he made significant contributions towards fulfilling the mission of the Council. He asked for a motion to approve the Resolution of Commendation.

Chief Fengel moved to approve the resolution. Mr. Farina seconded the motion. The motion was passed unanimously.

OLD BUSINESS

Vice-Chair Demuzio asked if there was any old business. There was no old business.

NEW BUSINESS

Vice-Chair Demuzio asked if there was any new business. Mr. Afeef asked to brief the Council members on a matter relating to the Open Meetings Act. He stated that there would be an agenda item relating to whether or not previous closed meetings' minutes must remain confidential at the next regularly scheduled Council meeting. Mr. Afeef stated that a memo would be included in the meeting materials for the next Council meeting advising the

Council members on what they need to consider before taking this vote. He noted that the Open Meetings Act allows public bodies such as the Council to close a portion of the meeting, and to keep confidential the minutes of those closed sessions, when the Council was involved in litigation and the members needed to discuss litigation issues. He further noted that the Open Meetings Act requires public bodies to periodically review the minutes of closed meetings.

CLOSED MEETING – PCIAA (LITIGATION) UPDATE (5 ILCS 120/2(c)(11))

Vice-Chair Demuzio stated that there were matters pertaining to the pending PCIAA litigation that needed to be discussed. He asked if there was a motion to close this portion of the meeting for this purpose. Chief Fengel moved to close the meeting. Mr. Johnson seconded the motion, and the Council voted unanimously to close the meeting for the purpose of discussing pending litigation.

All but the Council members and Mr. Stevens left the room during the closed session.

ADJOURN

The Council meeting was re-opened prior to adjournment. There were no additional items on the agenda after the closed session was concluded. Mr. Johnson moved to adjourn the meeting. Mr. Farina seconded the motion. The motion was approved by a unanimous voice vote and the meeting was adjourned.

Trust Fund reports - Behind divider one is the *Fiscal Status Report* for January 1, 2014 through March 31, 2014. As the report indicates, a balance of \$6,654,114 remains at the end of the reporting period.

Behind divider two is a *Cash Flow Projection Report* for 2014 and the *Lapse Funds Report* for 2009 - 2013. It is projected there will be a Trust Fund balance of \$1,994,155 at the end of 2014. Please review the footnotes located behind the report for additional fiscal disclosures.

Fiscal staff will be available to discuss the above reports.

Program vehicle fleet summary – Behind the third divider is a chart prepared by Vehicle Acquisition Specialist Luisa Salazar summarizing the entire vehicle fleet being utilized by the Council funded programs. The chart includes vehicles that are Council purchased, leased or insurance provided.

Staff activities – Below are highlights of staff activities for the period of February 1, 2014 – April 30, 2014.

- The Illinois Motor Vehicle Theft Prevention Council 2013 Annual Report has been completed. The report can be downloaded from the Council's website.
- Staff completed the mailing of 231 letters to insurance companies licensed to write passenger vehicle insurance coverage in Illinois. To date \$6,616,009 has been collected; in 2013, \$6,524,017 was collected.
- On March 21th, 2014, Vehicle Acquisition Specialist Luisa Salazar attended the International Association of Special Investigation Units (SIU), Illinois chapter meeting. The meeting was held at the Allstate Insurance offices in Woodridge, IL. Luisa met with SIU members for networking and the exchange of information.
- Luisa Salazar attended the Chicago Dialogue meeting held by National Insurance Crime Bureau on April 18, 2014. The meeting took place at the NICB headquarters in Des Plaines, Illinois. The purpose of the visit was to network with insurance companies and to exchange information regarding Council funded programs.

Projected grant amounts in 2014 are the State of Illinois budgeted (appropriation) of \$6.5 million.

It is reasonably possible that substantial "sweeps" to the fund could occur in the calendar years after 2013 based upon historical amounts determined by the State of Illinois and a reasonably possible conclusion in favor of the State of Illinois of the legal proceedings discussed in note 3.

It is reasonably possible that "sweeps" that materially affect the future results of the fund operations could occur as early as July 1, 2014. Budget reductions in 2014 and years after 2014 may be required as a result of sweeps that might occur.

2. The projected fund balance of \$1,994,155 at the end of the period will not be available for future programs unless the budgeted appropriation of \$6.5 million is increased to allow for this amount to be spent. Any lapsed funds in 2014 will increase the amount not available.

3. There two significant legal proceedings affecting the fund.

The Property and Casualty Insurers Association of America (PCIAA) filed a suit in the State of Illinois in 2006. The Governor and other top Illinois State officials (the State) are named as defendants. The suit asks for the return of over \$6 million of monies removed from the fund and for an injunction barring further removal of funds from the Trust Fund. An agreed court order between the plaintiff and defendants was entered on June 6, 2006. The State agreed that no money would be withdrawn from the fund and the plaintiff agreed to withdraw its motion for preliminary injunction.

The Office of the General Counsel of the Illinois Criminal Justice Information Authority – (OGC) reports that a motion for summary judgment filed by the defendants in the PCIAA suit in 2013 was granted by the trial court on August 27, 2013 dismissing all counts of PCIAA complaint. The plaintiff in the PCIAA case has reportedly filed an appeal of the trial court's decision to grant summary judgment in favor of the defendants.

The management of the Illinois Criminal Justice Information Authority stated in a report to the Illinois Office of the Comptroller that the probability of loss or "sweeps" to the trust fund as a result of a decision favorable to the State in the PCIAA litigation is <u>reasonably possible</u>. Under Statement of Accounting Standard No. 5, this is defined that the chance of the future event is more than remote but less than likely.

Quorum was established. State's Attorney Brady attended the meeting and was made a part of the GRC for the purposes of the committee deliberations.

Chairman Kilby gave a brief introduction.

Ron Litwin, formerly the Acting CFO, introduced Lorenzo Padron, ICJIA's new CFO. Mr. Padron gave a brief introduction of himself.

Pat Murphy from NEMAT was also on the telephone.

II. Approval of October 2, 2013 Grant Review Committee Meeting Summary

Chairman Kilby stated that the GRC meeting summary for the 10/2/13 meeting was behind Tab A of the meeting materials. He asked the members if there were any additions, deletions or questions regarding the summary. There were none. Chairman Kilby then asked for a motion to approve the meeting summary of 10/2/13.

Motion: approve the 10/2/13 meeting summary.

Motion: Director Demuzio Second: Mr. Cholewin

Vote: Approved unanimously

III. PROGRAM DIRECTOR'S REPORT

Chairman Kilby asked Program Director Greg Stevens to present his report. Mr. Stevens referenced his memo and the supporting materials found behind Tab B of the meeting materials.

Mr. Stevens reported that the expected expenses through 2/28/14 were \$1,083,090 and the reported expenses were \$754,541. Mr. Stevens further noted that the anticipated

balance of the trust fund at the end of 2014 would be \$1,994,155. There are fiscal footnotes and fiscal staff present to answer questions.

Next, Mr. Stevens discussed the report showing lapsed funds. He noted that in calendar year 2013 the total lapse amounted to less than 1% of the annual budget.

Mr. Cholewin made a comment about the administrative costs in 2012 and 2013 and observed that there was an increase in those costs. Mr. Litwin noted that the increase is a result of increases in pensions, medical benefit expenses, salaries and rent. Mr. Cholewin asked if these items will continue to increase. Mr. Litwin stated that he could not answer that question. Director Demuzio asked who was charged to the MVTPC Trust Fund, and Mr. Litwin noted that there are 4 FTE positions from ICJIA which are charged to the MVTPC Trust Fund.

Mr. Stevens made brief remarks on the funding chart, the summary chart of unit reports submitted, the program fleet vehicle summary and the report on staff activities.

With regard to staff activities, Mr. Stevens noted that the insurance company mailing was complete and to date the MVTPC had collected \$6,597,856. He reported that a FOIA to the Department of Insurance resulted in a list of every insurance company writing insurance policies that trigger a payment obligation to the MVTPC Trust Fund.

Mr. Stevens also noted that the Governor's proposed budget calls for an increase in the annual appropriation for the MVTPC from \$6.5 million to \$7 million.

IV. QUARTERLY ACTIVITY SUMMARY

Chairman Kilby next moved to the Quarterly Activity Summary item on the agenda. He noted that this report is prepared by the Illinois State Police Clearinghouse. He asked for review and feedback. There were no comments or questions.

V. PROGRAM PROFILE: NORTHEAST METRO AUTO THEFT TASK FORCE

Chairman Kilby noted that the next item on the agenda was a program profile of the Northeast Metro Auto Theft Task Force, and that the program profile was included in the meeting materials behind Tab D. He noted that the program would not make a presentation at the GRC meeting but will be presenting at the next Council meeting on May 21, 2014.

VI. OLD BUSINESS

There was no old business.

VII. NEW BUSINESS

Master Sergeant Ed Mirabelli's retirement just announced. Master Sergeant Gregg Cavanaugh's departure was announced as well. Both individuals were congratulated by the GRC members. ICJIA's Acting CFO Ron Litwin was recognized as well as he has retired and will soon be departing.

RE: Close Meeting Minutes

The Motor Vehicle Theft Prevention Council has held numerous closed meetings. All closed meetings have been pursuant to 5 ILCS 120/2(c)(11). Section 2(c)(11) allows a public body to close a meeting (or a portion of a meeting) to discuss pending litigation matters.

The meeting minutes and recordings of the closed meeting will not be made public as are the meeting minutes and recording of the open meeting. However, the Open Meetings Act requires a public body which holds a closed meeting to review the closed meeting minutes at least once every 6 months to determine whether the information in those meeting minutes need to remain closed. The Open Meetings Act gives public bodies the following guidance on what shall be considered in making this determination:

Each public body shall periodically, but no less than semi-annually, meet to review minutes of all closed meetings. At such meetings a determination shall be made, and reported in an open session that (1) the need for confidentiality still exists as to all or part of those minutes or (2) that the minutes or portions thereof no longer require confidential treatment and are available for public inspection. (5 ILCS 120/2.06(d))

In determining whether or not the public body requires the information in the closed meeting minutes/recording to remain closed, it is helpful to review the exception under which the meeting was closed. Section 2(c)(11) of the Open Meeting Act states as follows with regard to closing a meeting to discuss litigation:

Litigation, when an action against, affecting or on behalf of the particular public body has been filed and is pending before a court or administrative tribunal, or when the public body finds that an action is probable or imminent, in which case the basis for the finding shall be recorded and entered into the minutes of the closed meeting. (5 ILCS 120/2(c)(11))

Pursuant to this exception of the Open Meetings Act, a public body may close a meeting (subject to the other procedural requirements set forth in the Act) in order to consult with its attorney regarding pending litigation and to retain the attorney-client privilege over such communications.

The Office of General Counsel for ICJIA does not represent MVTPC with regard to this litigation so far as the MVTPC maintains a position contrary to that of the Office of the Governor. For this reason, ICJIA's attorneys have not participated in the closed meetings.

Introduction

The Northeast Metro Auto Theft Task Force (NEMAT), formerly named South Suburban Auto Theft Interdiction Network (SSATIN), Cook serves primarily Cook County, which consists of County the City of Chicago, as well as communities in the southern and western suburban Cook County areas. It is important to note that before 2003, the City of Chicago was not included in NEMAT's service area. Covering an area of 946 square miles, Cook County has the highest population density among Illinois' 102 counties. According to U.S. Census Bureau estimates for 2012, Cook County had a population of 5.23 million residents. ¹ As the state's most populated county, Cook County is a major center of motor vehicle traffic in Illinois. According to the Illinois Secretary of State's Office, more than 1.84 million passenger vehicles and trucks were registered in Cook County in 2012, the most vehicles of any Illinois county.²

This profile provides a general overview of the vehicle theft problem in Cook County and the activities the task force engages in to reduce vehicle theft. The statistics in this report look at Cook County, which includes the City of Chicago. The data is based on the Illinois State Police Uniform Crime Reports and the monthly data reports submitted by staff of NEMAT.


Motor Vehicle Theft in Cook County

According to the Illinois State Police, the number of motor vehicle thefts reported in the area covered by the Northeast Metro Auto Theft Task Force (NEMAT) decreased 61 percent between 1992 and 2011, from 58,238 thefts to 22,867 thefts. Motor vehicle thefts decreased 59 percent statewide during the same period. In 2011, Cook County accounted for approximately 79 percent of motor vehicle thefts in Illinois.

Between 1992 and 2011, a time when the population in the area covered by NEMAT remained stable, the motor vehicle theft rate in the region decreased 61 percent, from 1,120 to 438 offenses per 100,000 population. The statewide motor vehicle theft rate similarly decreased, from 609 to 226 offenses per 100,000 population. Figure 1 shows the motor vehicle theft rates in Illinois and the NEMAT area during this period.

Program Summary

The Northeast Metro Auto Theft (NEMAT) Task Force, originally founded as the South Suburban Auto Theft Interdiction Network (SSATIN), is the primary auto theft task force in Cook County. There are approximately 72 suburban cities, towns and villages, including the City of Chicago, within NEMAT's current jurisdictional boundaries. NEMAT is a multi-jurisdictional auto theft task force that combines the resources of the Illinois State Police, the Chicago Police Department, the Cook County State's Attorney's Investigator's Office, the Stone Park Police Department, the Broadview Police Department, the Illinois Secretary of State Police Department and the National Insurance Crime Bureau (NICB) to more effectively investigate and prosecute motor vehicle theft.


NEMAT is utilized by Cook County law enforcement agencies as a valuable resource to assist in investigating issues of motor vehicle theft as it pertains to their specific community. Furthermore, NEMAT has been able to act as a liaison between the different law enforcement agencies. NEMAT has identified motor vehicle theft trends and investigated groups of organized offenders who cross city and suburban law enforcement jurisdictions when committing motor vehicle theft and other related crimes, to include, but not limited to, insurance fraud, dealership thefts, and various financial frauds. The task force has also identified and investigated trends such as, Credit Privacy Number (CPN) Fraud, towing for scrap, Computer Fraud, Governmental Official Misconduct and international shipping of stolen vehicles, all of which facilitate motor vehicle theft.

Program Activity

Since the program began in November 1992, through December 2013, the Northeast Metro Auto Theft Task Force (NEMAT) has conducted 3,716 self-initiated and assisted investigations, resulting in 2,249 arrests and 812 convictions. From January 2001 through December 2013, NEMAT has conducted 2,367 self-initiated and assisted investigations, which have resulted in 1,183 arrests and 330 convictions. Figure 2 shows the number of motor vehicle theft investigations, arrests, and convictions for the program years 2001 through 2013.³



From November 1992 through 2013, the task force has recovered 3,919 vehicles worth an estimated \$66 million. Between January 2001 and December 2013, NEMAT has recovered 2,367 vehicles worth \$43 million. They have also made 170 recoveries of other equipment worth an estimated \$1.5 million since January 2006. Figure 3 shows the number of vehicle recoveries made by the task force since January 2001⁴.

Funding Summary

The Illinois Motor Vehicle Theft Prevention Act, which took effect on January 1, 1991, created the Illinois Motor Vehicle Theft Prevention Council. The Council has the statutory responsibility to "prevent, combat, and reduce motor vehicle theft in Illinois."⁵

The Act also established the Motor Vehicle Theft Prevention Trust Fund, a special trust fund in the State Treasury, from which the Council makes grants to eligible applicants for programs that address the problem of motor vehicle theft in Illinois. The Act requires all insurance companies licensed to write private passenger motor vehicle physical damage coverage in Illinois to pay annually into this trust fund an amount equal to \$1 for each earned car year of exposure for physical damage insurance coverage during the previous calendar year. Approximately \$6 million is collected each year.

Figure 4 summarizes NEMAT's program expenditures from 1993 through 2013. Expenditures are divided into six categories:

Personnel—includes salaries, social security, and fringe benefits for program staff.

Equipment—includes computers, communication devices, and other equipment with a cost greater than \$50.

Commodities—includes consumable supplies (such as office supplies) and equipment costing less than \$50.


Travel—includes lodging, food, and transportation expenses incurred by program staff while conducting official program-related business.

Contractual—includes facility costs, utilities, telephone service, equipment rentals, and wages for hourly personnel.

Other—includes any costs not covered by the above categories.

Conclusion

Since the Northeast Metro Auto Theft Task Force began operation, vehicle thefts have declined within the task force's jurisdiction. From 1992 to 2011, motor vehicle thefts in Cook County decreased 61 percent, from 58,238 to 22,867. The motor vehicle thefts decreased 42 percent in Cook County between 2000 and 2011.

Data on the value of stolen vehicles are not available at the state or county level; however, the FBI estimates that the average value of a vehicle stolen in the United States in 2012 was \$6,019. Based on this value, the increase of 96 auto thefts in the NEMAT area between 2010 and 2011 amounts to a loss of \$577,824.

In 2013, the task force received a total of \$584,110 in funding from the Illinois Motor Vehicle Theft Prevention Trust Fund, and has recovered an estimated \$4.1million in stolen vehicles, cargo, and parts. Combining the recovery value (\$4,070,210) with the loss from increased auto theft (-\$577,824), the task force has produced a \$3,492,386 million 'return' on its \$584,110 in funding, a "return rate" of \$5.98 for every \$1 of funding.
